Overview

As indicated in the CAA 2015-2018 Airspace Review Plan document, the airspace in the Waikato and Bay of Plenty region is under review with changes to be implemented in November 2016.

The review is aligned with the planned operations of new performance based navigation (PBN) procedures currently being designed by Airways Corporation of New Zealand.

This review comprises all the airspace detailed on the C3, C5 and C6 visual navigation charts covering the area south of Waihi Beach, westwards to Hamilton control zone-Te Kuiti-Taumarunui, eastwards to Opotiki-Lake Waikaremoana and as far south as Turangi.

Airspace reviewed includes:

- Controlled airspace
- VFR transit lanes
- General aviation areas
- Restricted areas
- Military operating areas
- Mandatory broadcast zones
- Danger areas
- Low flying zones
- VFR reporting points
- · Common frequency zones

Initial consultation commenced with airspace users at the end of May 2015. Cut-off for submissions was 7 August 2015.

Summary of requested airspace changes

Controlled airspace

Airways have reviewed the Tauranga, Hamilton and Rotorua control zones. Final designs are yet to be confirmed, as are any changes to control areas. Further consultation with users will take place in early November.

The majority of the submissions requested the lower level of some control areas, particularly those over the Matamata and Karapiro areas.

VFR transit lanes

Depending on the final CTR design, VFR transit lanes T251 Northern and T252 Te Awamutu, Hamilton will be amended.

There was a request for a VFR transit lane to be established in the west of Omokoroa in the Tauranga CTR.

General aviation areas

There were several submissions for amendments to the general aviation areas and to establish new ones.

NZG294 West Hamilton and NZG295 Pirongia




Figure 1 NZG294 and NZG295

During the 2015 Club Class National gliding competition two temporary general aviation areas were designated west of Hamilton. Now that there are no trans-Tasman flights to and from Hamilton, Gliding NZ have requested that consideration be given to designating these areas permanently. Refer to Figure 1.

Restricted areas

During gliding competitions held over the summer, there are two temporary restricted areas designated to allow gliders to operate in instrument meteorological conditions as per rule 104.53. Gliding NZ proposes amendments to the eastern and western boundaries

Military operating areas

There are no military operating areas in review area.

Mandatory broadcast zones

There were no requests for new, or changes to existing, MBZs in the review area.

Danger areas

There were no requests for new, or changes to existing, danger areas in the review area.

Low flying zones

One submission referred to the LFZs currently within the Hamilton and Tauranga CTRs. Depending on the final CTR designs, the airspace surrounding these LFZs may change to Class G.

Common frequency zones

There was one proposal suggesting the following:

- establish CFZs on either side of the Hamilton CTR
- · Peninsula CFZ extended to Tauranga CTR boundary

Following actions

Once the final petitions are received from Airways for controlled airspace changes, expected early December, CAA will begin final consultation on all proposed changes with users.

Submissions on the final airspace proposals will be invited from users between December 2015 and January 2016. Consultation meetings will be held late February/early March 2016.

Once the airspace user consultation meetings have taken place, there will be an opportunity to make further submissions prior to the visual navigation chart update cut-off date on 21 April 2016.
